3. WHEN AT ANY TIME THE BUYER DECIDES HE/SHE CANNOT KEEP OR DOES NOT WANT OR NEED ANY LONGER THE CAT WILL BE RETURNED TO BLUERIDGEMTN CATTERY.
4. ADEQUATE INDOOR FACILITIES WILL BE PROVIDED AND THE CAT WILL NOT BE ALLOWED TO ROAM OUTDOORS.
5. IF SAID CAT IS FOUND TO BE NEGLECTED OR IN ILL HEALTH FOR AN UNREASONABLE LENGTH OF TIME, BUYER WILL SURRENDER THE CAT TO SELLER UNCONDITIONALLY.

8. SELLER AGREES TO PROVIDE PEDIGREE AND REGISTRATION PAPERS ON THIS CAT UPON PRESENTATION OF A VETERINIANS CERTIFICATE OF NEUTERING OR SPAYING: YES WE AGREE NO\_\_\_\_\_.
